This person is someone who enjoys communicating with the community, empathetic, and a problem solver.

Separately from the above, the additional Public Health AmeriCorps Members will support the Patient Experience, Nursing, and Community Health Departments by helping improve CHMC 7-day readmission rate. This person will provide information on navigating the healthcare system and disease specific education to our patients who are at high risk for readmission. The ideal candidate will have the ability to support and coach patients but most importantly empower them to be their own advocates as they navigate the system. This person is someone who enjoys communicating with the community, empathetic, and a problem solver.

#### **Primary Responsibilities**

    - Step 1: Disease Specific education
    - Step 2: Healthcare System Education
    - Step 3: Follow-up appointment scheduling support
